**AN ORDINANCE TO AMEND ORDINANCE 627
AND CHAPTER 81, AT SECTION 81-3 OF THE BOROUGH
CODE OF THE BOROUGH OF TETERBORO ENTITLED
"CONSTRUCTION CODES, UNIFORM - FEES" TO REVISE
THE FEE SCHEDULE FOR CONSTRUCTION FEES**

BE IT ORDAINED by the Municipal Council of the Borough of Teterboro, in the County of Bergen and State of New Jersey, that:

Ordinance 627 and Chapter 81, at Section 81-3 of the Borough Code is hereby amended to provide a revised fee schedule and standards for the Borough of Teterboro Construction Department. The revised Fee Schedule below pertaining to Building Subcode fees for certain use groups amends the fees established by Ordinance 627 and Section 81-3 of the Borough Code:

§ 81-3. FEES:

(2) The Building Subcode fees for use groups A-1, A-2, A-3, A-4, A-5, B, E, F-1, F-2, H-1, H-2, H-3, H-4, H-5, I-1, I-2, I-3, I-4, M, R-1, S-1, S-2, and U shall be as follows:

- a. For new construction or additions: \$0.027 per cubic foot of building or structure volume, regardless of size, provided that the minimum fee shall be \$58.00.
- b. For reconstruction, renovations, alterations, and repairs: \$24.00 per \$1,000.00 of estimated cost.
